Minutes of the SPAN meeting held on 8<sup>th</sup> April 2024 held in St Peter's Church Hall The meeting started with the SPAN Prayer.

**Apologies** Caroline (Vice Chair) and Paul Manning, David Burton, Mary and Jonathan Holden, Fr Stephen Day, Fr David Hartley, Jeanette Davison, Patrick Reddin, Michael Barker (Treasurer), Sandie Tansey. **Minutes of the last meeting** were circulated, approved and signed.

Matters arising: 1. Appeal from Debbie Walden – Clare has sourced a Washing Machine (SPAN to give £ 70 and appealing for clothing for this family. 2. Should SPAN change its name? – ongoing discussion. It was noted that in SPAN's first meeting, 50 years ago "Service, People, Action and Now" was suggested. Last month "Supporting People Across the Nations" was mooted and tonight's gathering thought this more appropriate for today than "St Peter's Aid for the Needy".

Pastimes: Jim Murphy presented some information. Pastimes has re imagined as the St Peter's Community Warm Hub, serving people in our community. Open to anyone, showing our love in practical ways. Last year funding was received by the voluntary group, but this is hard to obtain, if you are not an audited charity. Jim has been seeking ways to fund this expansion where donations are NOT required of people who attend. The group has gone from an average size of 20 to over 40 and has functioned on around £ 200 a month for the past year. Noel Willis has helped by singing and there is a singing for mental health initiative. Four major reports recently have highlighted the benefits of people being part of a community when getting older, particularly those on their own, those without local family or in situation poverty. Jim is hoping Everyone Active may give support to the chair exercise initiative.

SPAN is being asked to consider giving support of £ 200 a month - Some extra Standing Orders with Gift Aid for example would make this easier to manage. How will this affect our ability to respond to appeals?

## Finance - Comments on the March 2024 Accounts

In the month we have £ 810 available for appeals due standing orders and cash collected through the churches. A figure of £ 1,500 has been donated which will be added to Lenten Alms appeals. The final figure foe House of Light and Hope will be determined at the next committee meeting. We are awaiting the setting up of standing orders for Hope Baby Clinic and Young People First. Next month we will draw down the last of our Lagacy funds given prior to the Frank Garvey Legacy. After that we will draw £ 500 a month from Frank's general legacy to SPAN appeals. This should last for around 3 years. Frank's specific legacy for 'Starving Africa' has already been allocated.

[£ 104.58 will be added to amounts earmarked for hospitals at Nyenga, Uganda and Ortum, Kenya.]

Appeals - \* indicates that attachments with further details were sent out ahead of the meeting,

- Fr Stephen Oribdhogu, Nebbi diocese Uganda NEW "I am inquiring whether it is possible to get some assistance from St. Peter's Aid for the Needy for some three young people (two girls and one boy) who are ready to go to school, but do not have any means to provide for their tuition. They have expressed interest in vocational training in the nearest Vocational school run by the Sisters of Daughters of Providence in the diocese. The tuition for these young people for the whole academic year is 500 pounds, an equivalent of Uganda shillings 2,455,000/-. This includes all their functional and hostel fees. My office has also received many orphans looking for some kind of support." Agreed to ask some questions like would this be an ongoing commitment of £ 500, what would we hear about the children, what / whose account would the funds be transferred to.
- Make them Smile \* NEW "To relieve poverty and sickness and to preserve the health of children."
   Agreed not to support.
- IRT International Refugee Trust \* "Assisting Displaced Families in Jordan." £ 500 Agreed for the 2 Italian hospitals in Amman and Karak in Jordan that we have supported in the past.
- LAFF, Latin America Foundation for the Future in Peru \* "We work with local partners to improve their long-term ability to provide quality education and personal development to children and young people in vulnerable conditions in Peru." £ 300 Agreed for Casa Mantay supporting teenage mothers.
