#### **SPAN Donations Allocation – first quarter 2023**

How have your SPAN donations been allocated in the first three months of 2023? Our core support has given: the Leamington and Warwick District Foodbank £300; Saturday Friendship Group focussing on the homeless £600; New Chapters setting out to give direct help for local addiction sufferers £300 (plus £1,000 from the SPAN Quiz night); St Francis Leprosy Hospital in Nyenga, Uganda £616; Ortum Mission Hospital in Kitale, Kenya £616; Fr Mayele in Uganda, supporting the education of vulnerable children £111; House of Light and Hope in Beirut, Lebanon, supporting the work of Dr Robert Caracache sheltering and educating street children £249 (plus a £1,500 private donation).



At our meetings we receive correspondence from previous recipients and new appeals. We consider how best to respond to the needs presented. We agreed to help: Starfish Malawi alleviating poverty through education, vocational training and use of sustainable resources through a number of projects in Malawi £400; for CAFOD's work in Darfur, Sudan £300; Daylight Christian Prison Trust for visits

to prisoners £200; Guy's Gift a charity supporting bereaved young people in Coventry and Warwickshire. £350; Hope House Babies Home Nairobi, Kenya, a home for abandoned babies and babies whose mothers have offered them for adoption £250; Rosa Care Zimbabwe, assisting orphans and vulnerable children, also aimed at preventing and responding to violence against girls', children and women with disabilities £250; Educaid providing high quality, holistic education among the under-privileged young people of Sierra Leone £250; Legs4Africa recycling prosthetic leg parts helping 25 amputees across Africa access unwanted prosthetics from the UK £500; CAFOD campaign to Fix the Food System £1,000; Fr Siluvai Nathan in India, private donation £1,000; CAFOD Syria and Turkey earthquake appeal £1,000

SPAN has also responded to specific requests to help local families from the Local Authority's Family Support Services to provide: a single bed for a 12-year-old following rehousing £185; a double bed for a Ukrainian family moving into social housing £300; a laptop for a child no longer able to attend school £240. We are currently being asked if we can help with two or three other families in need.

We celebrate Pope Francis' ten years as Pope. His fellow Bishops (led by the Holy Spirit) tasked him with reviewing the Roman Curia, addressing the shortcomings of the clergy abuse crisis and applying the thinking of the Second Vatican Council. All challenging projects. Characteristically Pope Francis has taken time to engage others in his actions. We pray for his health.

The Walking Together Synod (and the Diocesan Vision) call us to continue our journey of faith from our desire to know more of the love and mercy of Jesus, evidenced in scripture, to act as the People of God – Vatican II asserted that we are all called to community and our joy in knowing Christ should lead us to share this with others. To do this better we need enhance our Eucharistic community, have formation to appreciate more about scripture and tradition, so that we are more confident to share our faith with others.

Vatican II recognised that the Holy Spirit is not constrained to the Catholic Church. It is easy to forget that the church has got things very wrong in the past: proclaiming that the earth revolves around the sun was deemed heretical, condoning slavery for many centuries, siding with fascist regimes at times, covering up abuse.

We have to be cautious about tradition, the formal church has expressed too much in Black or White. Our understanding of so many issues has evolved in the past 60 years. There are shades and colours that enrich God's world:

Whilst holding up marriage (or celibacy) as a lifetime commitment, circumstances do prevail where our pastors should be able to offer the mercy, forgiveness and hope of God for all (including the divorced and remarried) and not just in some token way;

Pope Francis told Chilean abuse survivor Juan Carlos Cruz: "that you are gay does not matter. God made you like that and loves you like this and I don't care. The Pope loves you like this. You have to be happy with who you are." Pope Francis also said, "If a person is gay and seeks the Lord and has good will, who am I to judge that person? You should not discriminate against or marginalise these people"; and

I believe that the Church missed the boat of accepting gay couples as having an agreed status different to marriage, but now needs to accept gay marriage and bless such unions which allow our God given sexuality to be lovingly expressed.

The Eucharist is food for the traveller NOT just for the holy! Vatican II simply says we are all guests at the Lord's party. Who are we to say, you are not good enough to be here.
